# Re: Your child's flu vaccination e-consent

The Child and Family Health Surrey Immunisation Team is visiting Bagshot Infant school on **Thursday 2<sup>nd</sup> November 2023** to deliver Influenza (flu) vaccinations via nasal spray.

## Please complete the e-consent form by 4pm on 27th October 2023 by visiting:

- <u>www.surreyimmunisations.co.uk</u> and entering your school's unique code **SR124996**
- If you do not want your child to receive a vaccine, then please fill in the 'No' box.
- If you do not want your child to receive the nasal spray vaccine on the basis of porcine gelatine, please fill in the 'No' box indicating this, and you will be given the opportunity to consent for an alternative vaccination. This vaccination is delivered by injection into the arm (intramuscularly) and does not contain any porcine DNA agents. We will deliver this in school when we visit, if you would like you child to receive this vaccination in a clinic, please contact us on the above number or email.

An automated email will be sent to you on completion of the e-consent form from Cinnamon Digital Applications (who host the website portal for us). If you do not receive this, please check in your junk email or contact the Immunisation team.

### GDPR

On the 25 May 2018 the new EU General Data Protection Regulation (GDPR) came into force bringing with it improvements to Data Protection Regulations. While we will continue to seek your explicit consent for the treatment of your child/children, your information will be processed under the following GDPR articles:

Article 6 (1) (e)

For the performance of a task carried out in the public interest or in the exercise of official authority.

## Article 9(2)(h)

Necessary for the reasons of preventative or occupational medicine, for assessing the working capacity of the employee, medical diagnosis, the provision of health or social care or treatment or management of health or social care systems and services on the basis of Union or Member State law or a contract with a health professional.
